White River Connect, LLC (Connect) is committed to respecting and protecting our customers' privacy. Connect obtains and uses customer information for business purposes only and to enable Connect to provide its customers with the best service possible. Please review this Privacy Policy to better understand how we collect information, how that information is used, and your options as to the collection and use of your information. This Privacy Policy is applicable to Connect's customers and visitors to its website and is intended to provide information regarding Connect's methods for collecting and use of the information.

What Types of Information Does Connect Collect?

Whether you are communicating with Connect or using its services, Connect collect both personal and non-personal information. "Personal may collect both personal and non-personal information. Information" refers to information that is particular to you, such as your name, address, phone number, email address, billing information, such as account number, date of birth, credit card number, user IDs, and other information as provided to us by a subscriber or user of our services. "Non-personal information" refers to information that does not by itself identify a specific individual. This information includes websites visited, network traffic data, services and features used or call record details. Connect may use "cookies" to collect information to enhance your experience.

How Do We Collect Information from You?

Connect may collect information from you through communications such as via the phone, website, internet traffic, email, mail, surveys, mobile applications, or through the services provided to you as a customer.

Information may be collected in the following ways:

Browsing Our Site

- IP addresses may be collected for the purposes of system administration, gathering broad demographic information, and monitoring the level of site activity.
- Information may be collected regarding the referring URL, browser used to come to our site, and the pages of our site that you viewed during your visit and any search terms entered on our site.
- Emails may be sent by a customer to Connect on this website. Connect máy retain the information in any email that you send to us, such as your name, email, address, or phone number.

Voice and Internet Services

Connect may monitor the network and take measurements of network performance and the performance of your Internet connection to improve the customer's or Connect's overall service levels.

- During communication with Connect for service support, we may also access information about your customer premise equipment such as computers and wireless devices or other device settings to provide customized technical support or to install specific applications or services for your use.
- Connect reserves the right to access broadband traffic from individual accounts for the purpose of general maintenance and management of the network, as well as upon request by law enforcement.

Provision of Information by Third Parties

How is Your Personal Information Used?

Connect does not rent, sell, or trade your private information to any non-affiliated third party.

With Whom Do We Share Your Information

- With our Customers: Connect may share generalized personal information with our customers to make sure your experience is at the highest level possible and that you have the fullest service that Connect has to offer. Information shared will never include personally identifiable information. This is subject to applicable legal restrictions, such as those that exist for Customer Proprietary Network Information (CPNI).
- With Vendors that Perform Services for Connect: We may share
 your personal information with vendors that perform services on our
 behalf and only as necessary for them to perform those services.
 We a) require those vendors to protect any personal information
 they may receive in a professional manner consistent with our policy
 and b) we will not provide personal information to anyone for the
 marketing of their own products and services without your consent.

Other Circumstances Which May Warrant Sharing Your Personal Information

- Complying with any court ordered subpoenas or any other legal process.
- To assist with identity verification and prevent fraud and identity theft.
- Enforcing our agreement and property rights.
- · For safety reasons.
- · Obtaining payments for products and services that appear on your

Connect billing statements, or those of our customers, including the transfer or sale of delinquent accounts to third parties for collection.

Internet Use

Any websites of Connect may contain links to other websites. Connect is not responsible for the content or privacy policies of other sites. Even though Connect will use its best efforts to assure privacy and confidentiality, material on the web, e-mail, or other electronic communications cannot be guaranteed to be protected against access by unauthorized persons. Access by unauthorized persons can be obtained without your consent or our consent. This is simply a function of technology in today's environment.

Protection of Underage Children

Connect's websites or usage of is not intended for children under the age of 15 years. Connect does not knowingly collect or solicit personal information from anyone under the age of 15 or knowingly allow such persons to register for use of any of our products or services. In the event Connect learns that we have collected personal information from a child under the age of 15 years without verification or parental consent, we will delete such information as quickly as possible.

How Does Connect Protect Your Personal Information?

SMS Messaging Service
